Dear Show Management,

Thank you for your interest in becoming a sanctioned IJBBA show. The IJBBA has become well known throughout the United States through the hard work and efforts of people as yourself in making successful sanctioned shows for our youth. As a sanctioned IJBBA show, please note that you have very specific obligations that must be adhered to so that there is consistency between all IJBBA sanctioned shows across Iowa. Your show must be willing to follow all the enclosed rules and they must be enforced fairly and practically. By meeting the following obligations you will be on your way to providing a successful sanctioned IJBBA show.

## **Obligations For Sanctioning:**

- Complete the enclosed Official Iowa Junior Beef Breeds Association Sanctioning Contract.
- Pay on our website with a credit card under the Sanctioned Shows Tab or enclose a check with the contract for \$150 payable to the Iowa Junior Beef Breeds Association. **\$300 if hosting 2 shows.**
- ***All Previous shows MUST have a contract to Kim Lewis by February 1<sup>st</sup>, 2020 in order to have the same date as last year. After February 1<sup>st</sup> dates will become available for shows to have a new date. No shows will be sanctioned after February 15<sup>th</sup>, 2020. As we will be publishing the final sanctioned show schedule at the 2020 Iowa Beef Expo.***
- ***Show must be sanctioned at least 45 days prior to show date.***
- Email a show flyer which will be used on the IJBBA website and IJBBA Facebook page to advertise your show. The IJBBA will promote your show provided it is sanctioned at least 30 days prior to the show. Please include a contact number on your show flyer that questions can be directed to.
- **Return the contract, pay online or send check, and show flyer (prefer PDF form) to Kim Lewis at the address shown below.**
- Follow the enclosed show sanctioning rules.
- We will send an email after your show is sanctioned with the 2020 Excel template to fill out for points.

Once you have fulfilled your obligations, you will receive a confirmation email allowing you to promote your show as an IJBBA sanctioned show. If you do not receive confirmation within two weeks, please contact Kim Lewis.
